CORONAVIRUS/COVID-19 RELEASE OF LIABILITY & PROCEDURES

PROCEDURES FOR CURLING WITH XXXXX CURLING CLUB

I understand and agree that in order to participate in any activities associated with curling, including but not limited to curling leagues, learn to curl sessions, open ice games or practice, curling instruction, coaching, ice crew activities, competitive playdowns, friendly tournaments and events hosted by XXXXX CURLING CLUB, at [rink, - arena club] that I will be subject to the following best practices:

- Wearing a mask that covers the nose and mouth at all times while inside [rink];
- Social distancing upon entering [rink];
- Handwashing hygiene and use of hand sanitizer as needed per YYYYY County protocols;
- Covering mouth when coughing and/or sneezing;
- Being asked to leave if I have a fever or signs of being sick;
- Adhering to County mandates if deemed high risk by county, state, federal, or CDC guidelines.

I further understand that should I experience recognized symptoms of COVID-19, such as fever, fatigue, dry cough or difficulty breathing, I shall not attend XXXXX CURLING CLUB activities or if I am at such an activity, I shall voluntarily leave the building and not return until I have fully recovered.

RELEASE OF LIABILITY

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself including, but not limited to, personal injury, disability, and death, illness, damage, loss, claim, liability, or expense, of any kind that I may experience or incur in connection with my attendance at [rink] or participation in XXXXX CURLING CLUB events, activities, and/or services.
